

CAS faculty and other 2%^{2%}1% researchers have submitted Federal 206 proposals as Lead PI and 21% Foundations, Non-Profit 33 as collaborators (timephased goal for Q2 was more State than 52 collaborative Other proposals) for 239 total submissions including seven Commercial non-competing continuations. 74%
